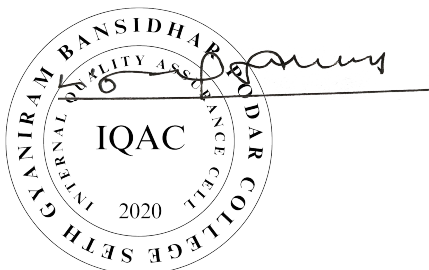

### **5.2.1 Number of outgoing students placed during the year**



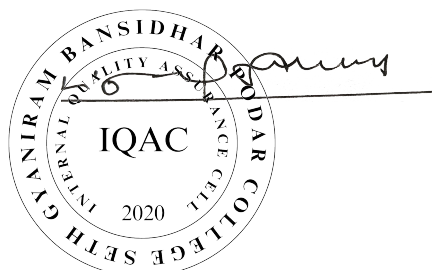

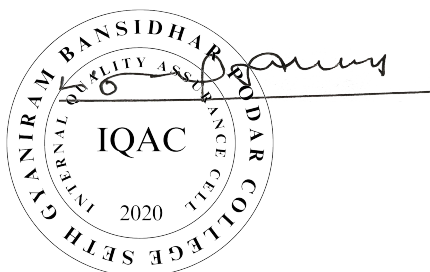
### Report on Campus Placement Fair

There were three rounds of interview, the details are as under:

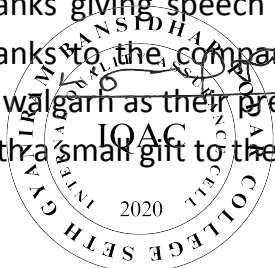
First Round : Written test (objective type multiple choice questions) of one hour

A total of 81 students participated in the event and the basic eligibility criteria set by the bank for recruitment was graduation in any stream with basic knowledge of computers.

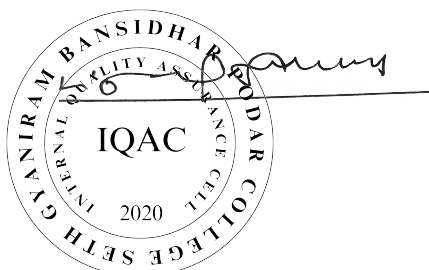
The Interview process was as below:

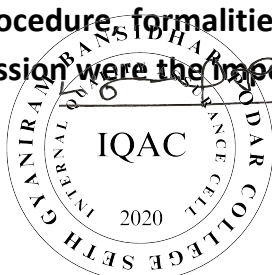
