No. SR/S9/Z-08/2018 dated 30.01.2019. In addition to the above, the grant of Research Associate-I to you shall be regulated as per the additional terms and conditions as follows: -1. Your appointment will be for a period of two years or until the completion of the project and/or availability of funds, whichever is earlier. Your performance will be evaluated at the end of the first year, and the decision regarding the continuation to second year will be based on your research progress and overall performance. You are required to submit your progress report and request for a second-year extension to your reporting officer at least one month prior to the completion of your first year. 2. 
