Preamble

Seth Gyaniram Bansidhar Podar College, Nawalgarh, is committed to providing a safe, secure, and ragging-free environment for all students. Ragging in any form is strictly prohibited within the college premises, hostels, transport, or outside. This policy aligns with UGC Regulations 2009 and Supreme Court directives for zero tolerance against ragging.

Definition of Ragging

Ragging is any act (physical, verbal, psychological, or sexual) that causes annoyance, hardship, or harm to a student's body or mind, including:

- Teasing, abusing, threatening, or playing practical jokes.
- Any disruption to academic or co-curricular activities.
- Exploitation for financial or other gains.

Objectives

- Sensitize students, parents, and staff against ragging.
- Ensure prompt redressal of complaints.
- Impose strict penalties on perpetrators.
